On July 31, 2012, Dr. Shulman filed an application for re-registration of his license to practice medicine and surgery in Wisconsin, which lapsed on December 31, 1981. Based upon the length of time Dr. Shulman had not practiced medicine and his desire to resume practice in area of psychiatry, the Board granted Dr. Shulman a non-disciplinary limited license on February 11, 2013. As a condition of the limitation, Dr. Shulman was required to complete a comprehensive review course in psychiatry prior to engaging in the practice of medicine and surgery in the state of Wisconsin. Respondent has submitted proof that he successfully completed the education terms of the Order and, as a result, the following is entered:

ORDER

NOW, THEREFORE, IT IS ORDERED that Dr. Shulman's license to practice medicine and surgery in the state of Wisconsin (#19723-20) is hereby returned to full, unrestricted status.

IT IS FURTHER ORDERED that all limitations and encumbrances upon Dr. Shulman's credential be, and hereby are, removed.

This Order is effective the date of its signing.
