On January 29, 2013, Respondent Jennifer S. Pipes, R.N., entered into a Stipulation with the Division of Legal Services and Compliance¹ (Division) to resolve Division Case No. 12 NUR 400. On February 1, 2013, the Division submitted the Stipulation and related proposed Final Decision and Order to the March 14, 2013 Wisconsin Board of Nursing (Board) meeting agenda. On March 14, 2013, the Board adopted the Stipulation and entered the Final Decision and Order.

Subsequent to the March 14, 2013 Board meeting, the Division discovered that it had added an incorrect version of the proposed Final Decision and Order to the Board's agenda. The Division requested that the Board rescind the Final Decision and Order entered on March 14, 2013. The Board considered the request at its meeting on April 11, 2013, and orders as follows:

ORDER

The Final Decision and Order in the Matter of Disciplinary Proceedings Against Jennifer S. Pipes R.N., that was entered by the Board on March 14, 2013, is hereby RESCINDED.
