PROCEDURAL HISTORY

The parties have agreed to the terms and conditions of the attached Stipulation as an Amended Interim Order in this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order:

FINDINGS OF FACT

1. Respondent Levi Leong, M.D., (dob December 7, 1975), is licensed in the State of Wisconsin to practice medicine and surgery, having license number 20-54491, first issued on May 12, 2010 with registration current through October 31, 2013. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 691 Mindy Creek, St. Croix Falls, Wisconsin 54024. However, the Division of Legal Services and Compliance (Division) has received information that Respondent's current address is 941 Pinethistle Avenue, Bloomfield Hills, Michigan 48302.

- 2. Respondent is certified in general psychiatry by the American Board of Psychiatry & Neurology.
- 3. On August 15, 2012, the Division of Legal Services and Compliance (Division) opened investigation 12 MED 289 of Respondent on behalf of the Board. The investigation is based on allegations by one of Respondent's patients, Patient X, an adult female. Patient X has alleged that during the period of time that Respondent was treating her (fall of 2011 through May of 2012), they began dating and engaged in sexual relations. These allegations are also the subject of criminal charges (third degree criminal sexual conduct, therapist and patient) against Respondent in State of Minnesota, County of Chisago, District Court, 10th Judicial District, Court File No. 13-CR-12-955.
- 4. The Board has not made a determination as to the validity of the above allegations.
- 5. Respondent has voluntarily agreed not to engage in the practice of medicine pending the final resolution of this disciplinary matter in the event of a mis-trial, hung jury or that he is found guilty of the criminal charge or any lesser included offense. In the event that Respondent is found not guilty, has a directed verdict entered in his favor or the criminal charges are dismissed, Respondent has voluntarily agreed not to engage in the practice of medicine until the Department Monitor is provided proof that one of those three events has occurred.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The license to practice medicine and surgery in the state of Wisconsin of Respondent Levi Leong, M.D., is hereby SUSPENDED. In the event of a mis-trial, hung jury or that that he is found guilty in Chisago County Court File No. 13-CR-12-955 of the criminal charge or any lesser included offense, the SUSPENSION will remain in effect until the Board issues a Final Decision and Order in this disciplinary matter. In the alternative, if Respondent is found not guilty, has a directed verdict entered in his favor or the criminal charges are dismissed, the Interim SUSPENSION would be terminated upon receipt by the Department Monitor of a copy of an Order of Dismissal, an Order of a Directed Verdict in his favor or a Not Guilty Verdict by the jury in Chisago County Court File No. 13-CR-12-955.

2. This Order is effective on the date of its signing.
