On April 1, 2013, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay six hundred fifty six dollars (\$656.00) in costs of the proceeding and forfeiture within ninety (90) days. On October 14, 2013, Respondent's manicurist's license was suspended for failure to pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent has now paid the costs of the proceeding in full, the following is entered:

ORDER

1. The suspension is terminated and Respondent's manicurist's license (#6679-85) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
