The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Keith A. Schmidt (dob January 5, 1981) is licensed in the State of Wisconsin as a Private Security Person, having license number 40424-108, first issued on April 29, 2010 and current through August 31, 2014. Respondent's most recent address on file with the Department is 426 Mill Street, Tomahawk, Wisconsin 54487.
- 2. In August 2012, Respondent submitted an online renewal application for his private security person license and answered "NO" to the following questions:

In the past two years, have you been convicted of a MISDEMEANOR, OPERATING WHILE INTOXICATED (OWI), a VIOLATION of any federal, state or local law, OR are criminal charges or OWI charges currently pending against you in this or any other state?

In the past two years, have you been convicted of a VIOLATION of ANY federal, state or local law or municipal ordinance that is punishable by a fine or forfeiture in this or any other state, OR are federal, state or municipal charges currently pending against you?

In the past two years, have you been convicted of a FELONY in this state or any other state, OR are FELONY charges currently pending against you?

- 3. A subsequent Criminal Information Bureau check by the Department revealed a pending criminal charge against Respondent.
- 4. Respondent's private security person license was renewed on September 20, 2012.
- 5. On January 10, 2013, the matter was referred to the Division of Legal Services and Compliance and Case Number 13 RSG 003 was subsequently opened for investigation.
- 6. Court records obtained from Respondent's attorney reveal that on or about May 15, 2012, Respondent was charged with felony Physical Abuse of a Child Intentionally Cause Bodily Harm (Lincoln County Case Number 2012CF000078).
- 7. On December 14, 2012, Respondent was convicted of amended charges of misdemeanor Disorderly Conduct (2 counts). Respondent was sentenced, in part, to 12 months Probation (stayed) and counseling/education as recommended by agent.
- 8. Respondent failed to notify the Department of the convictions within 48 hours after the judgment of conviction.
- 9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent engaged in conduct reflecting adversely on his professional qualification pursuant to Wis. Admin. Code § SPS 35.01(2) by violating a law the circumstances of which substantially relate to the practice of a private security person.

- 3. By the conduct described in the Findings of Fact, Respondent engaged in conduct reflecting adversely on his professional qualification pursuant to Wis. Admin. Code § SPS 35.01(17) by providing false information in the application for a credential.
- 4. By the conduct described in the Findings of Fact, Respondent violated Wis. Stat. § 440.26(4m)(b) and Wis. Admin. Code § SPS 35.01(2) by failing to report his convictions to the Department within 48 hours after the judgment of conviction.
- 5. As a result of the violations noted in the Conclusions of Law, Respondent is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)1-4 and Wis. Admin. Code § SPS 35.01.

ORDER

- 1. The attached Stipulation is accepted.
- 2. The Private Security Person license of Keith A. Schmidt (license number 40424-108) is hereby SUSPENDED for a period of 20 days beginning 15 days after the date of this Order.
- 3. The Private Security Person license of Keith A. Schmidt (license number 40424-108) is LIMITED as follows:
 - a. Respondent shall successfully complete all terms of the sentence or probation ordered by the Lincoln County Circuit Court in case number 2012CF000078.
 - b. Respondent shall submit proof of completion of all terms of the sentence or probation in the form of verification from the Lincoln County Circuit Court to the Department Monitor at the address stated below.
 - c. This Limitation shall be removed from Respondent's license after he has satisfied the Department or its designee that he has successfully completed all the terms of the ordered sentence or probation.
- 4. In the event Respondent fails to successfully complete all terms of the sentence or probation as ordered by the Lincoln County Circuit Court in case number 2012CF000078, Respondent's license, number 40424-108, may, in the discretion of the Department or its designee, be REVOKED, without further notice or hearing.
- 5. Within 90 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$228.00.
- 6. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent by Respondent to the Department Monitor at the address below:

- 7. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered and as set forth above, Respondent's license (no. 40424-108) may, in the discretion of the Department, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
 - 8. This Order is effective on the date of its signing.
