The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Veterinary Examining Board (Board.) The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

## **FINDINGS OF FACT**

1. Respondent Leslie Parr, C.V.T., (dob: April 17, 1957) is licensed in the State of Wisconsin as a veterinary technician, having license number 7800069-51, first issued on September 27, 1978, and current through December 14, 2013. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 899 County Road JG, Mount Horeb, Wisconsin 53572.

- 2. On July 6, 2010, Respondent provided emergent services to a canine, Sugar, at the owner's home located in Mount Horeb, Wisconsin. At the direction of a veterinarian, Respondent administered diazepam, a schedule IV medication, to Sugar.
- 3. Respondent failed to fully document in the veterinary patient medical record the patient care that she provided Sugar, including the administration of the controlled substance.
- 4. Respondent failed to document in the veterinary patient medical record the veterinarian's prescription order for the controlled substance.
- 5. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

## **CONCLUSIONS OF LAW**

- 1. The Wisconsin Veterinary Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 453.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent Leslie Parr, C.V.T., violated Wis. Admin. Code §§ VE 7.03(2)(k) and (l), and Wis. Admin. Code § VE 9.05(8) by failing to document the care and treatment that she provided and the drugs prescribed or dispensed in the veterinary patient medical record.
- 3. As a result of the above violations, Respondent Leslie Parr, C.V.T., is subject to discipline pursuant to Wis. Stat. § 453.07.

## **ORDER**

- 1. The attached Stipulation is accepted.
- 2. Respondent Leslie Parr, C.V.T., is REPRIMANDED.
- 3. Within 90 days from the date of this Order, Respondent Leslie Parr, C.V.T., shall pay COSTS of this matter in the amount of \$200.00.
- 4. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

- 5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered, Respondent's license (7800069-51) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
  - 6. This Order is effective on the date of its signing.
