The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Danny R. Berndt, L.P.N., (dob September 7, 1971) is licensed in the State of Wisconsin as a practical nurse, having license number 311437-31, first issued on June 25, 2009. The license expired on April 30, 2013, and has not been renewed. Pursuant to Wis. Stat. § 440.08(3), Respondent retains the right to renew upon payment of a fee until April 29, 2018. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 421 West 10th Avenue, Oshkosh, Wisconsin 54902.

- 2. On September 11, 2012, Respondent was found unconscious in his apartment from an accidental overdose of heroin. On September 14, 2012, Respondent was charged with possession of narcotic drugs in Winnebago County (Case Number 12 CF 633).
- 3. On October 31, 2012, Respondent completed a 28-day inpatient treatment program. Upon his discharge from the program, he was diagnosed with the following: alcohol dependence with physiological dependence opioid dependence without physiological dependence and amphetamine abuse.
- 4. On November 12, 2012, Respondent plead no contest to possession of a narcotic, a class I felony and was placed on a deferred prosecution agreement for two years.
- 5. On January 4, 2013, Respondent was admitted into the Professional Assistance Procedure (PAP).
- 6. On January 22, 2013, Respondent submitted a letter to the PAP Coordinator stating he no longer was able to continue in PAP. The PAP Coordinator spoke with Respondent on the phone and Respondent acknowledged that he understood disciplinary action may result in removal from PAP. Respondent also stated he understood discipline could include suspension of his practical nursing license.
- 7. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Danny R. Berndt, L.P.N., engaged in unprofessional conduct as defined in Wis. Admin. Code § N 7.04(1) by violating the law substantially related to the practice of practical nursing.
- 3. By the conduct described in the Findings of Fact, Danny R. Berndt, L.P.N., engaged in unprofessional conduct as defined in Wis. Admin. Code § N 7.04(2) by obtaining any drug other than in the course of legitimate practice or as otherwise prohibited by law.
- 4. As a result of the above conduct, Danny R. Berndt, L.P.N., is subject to discipline pursuant to Wis. Stat. § 441.07(1)(b) and (d).

<u>ORDER</u>

1. The attached Stipulation is accepted.

- 2. The SURRENDER of the license and privilege of Danny R. Berndt, L.P.N., (license no. 311437-31) to practice nursing in the State of Wisconsin or under another state license pursuant to the Nurse Licensure Compact is hereby accepted.
- 3. In the event that Respondent petitions the Board of Nursing for re-licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license granted shall be in the discretion of the Board.
- 4. Within 120 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$550.00.
- 5. Payment of costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:
