On January 23, 2013, the Wisconsin Board of Nursing ("Board") issued a denial of Lisa A. Schipp's application for licensure as a registered nurse by endorsement (# 453928). Ms. Schipp submitted a timely request for hearing on the denial, as provided for in Wis. Admin. Code § DSPS 1.07. Ms. Schipp's hearing request was reviewed under the procedures of Wis. Admin. Code § DSPS 1.08, and subsequently granted.

At its regularly scheduled meeting on June 13, 2013, the Board reconsidered the decision to deny Ms. Schipp's application (# 453928), and concluded that the denial should be rescinded. The Board therefore issues the following Order:

IT IS HEREBY ORDERED that the denial of Lisa A. Schipp's application for licensure as a registered nurse by endorsement (# 453928) is RESCINDED.

IT IS FURTHER ORDERED that the application for licensure as a registered nurse by endorsement of Lisa A. Schipp be granted upon her satisfaction of all other conditions for such licensure.
