The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Daniel T. Cabot, D.O., (dob: February 7, 1969) is licensed in the State of Wisconsin to practice medicine and surgery, having license number 51010-21, first issued on October 19, 2007 and current through February 28, 2014. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 1507 Tower Avenue # 307, Superior, Wisconsin 54880.

2. Respondent is also licensed in the State of Minnesota as a physician and surgeon. (license # 47396).

3. In February 2011, Respondent was evaluated for a health matter, substantially related to the practice of medicine. He does not agree with and has not complied with the resulting treatment recommendations.

4. Respondent neither admits nor denies these facts, however, in the interest to resolve this matter, consents to this Final Decision and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

<u>ORDER</u>

1. The attached Stipulation is accepted.

2. The VOLUNTARY SURRENDER by Respondent Daniel T. Cabot, D.O., of his registration to practice medicine and surgery in the State of Wisconsin (license number 51010-21) and his right to renew that registration is hereby ACCEPTED.

3. This action constitutes Respondent's permanent relinquishment of his license (license number 51010-21) to practice medicine and surgery in the State of Wisconsin. Respondent Daniel T. Cabot, D.O., will not reapply for registration to practice medicine and surgery in the State of Wisconsin at any time in the future.

4. This Order is effective on the date of its signing.
