The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Sandra Olson, R.N., (dob April 11, 1959) is licensed in the State of Wisconsin as a professional nurse, having license number 119811-30, first issued on June 23, 1995 and current through February 28, 2014. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is P.O. Box 185, Woodruff, Wisconsin 54568.

2. At all times relevant to this proceeding, Respondent was employed as a professional nurse at a medical center (Center), located in Green Bay, Wisconsin.

3. On or about January 18, 2013, Center discovered discrepancies between Respondent's Pyxis dispensation and administration documentation of Nubain®.

4. Respondent removed Nubain® from Pyxis against protocol. Respondent failed to document administration or wasting the medication.

5. On or about January 21, 2013, Center interviewed Respondent regarding the missing medications. Respondent admitted to ingesting the medication on multiple occasions when it should have been wasted.

6. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. Nubain[®] is a brand name for nalbuphine. Pursuant to Wis. Stat. § 961.16(2)(a), nalbuphine is a schedule II controlled substance for which, under the circumstances at issue, a prescription is required pursuant to Wis. Stat. § 961.38(3).

3. By the conduct described in the Findings of Fact, Sandra Olson, R.N., engaged in unprofessional conduct as defined in Wis. Admin. Code \S N 7.04(2) by obtaining any drug other than in the course of legitimate practice or as otherwise prohibited by law.

4. As a result of the above violations, Sandra Olson, R.N., is subject to discipline pursuant to Wis. Stat. 441.07(1)(b) and (d).

<u>ORDER</u>

1. The attached Stipulation is accepted.

2. The SURRENDER of the license and privilege of Sandra Olson, R.N., (license no. 119811-30) to practice nursing in the State of Wisconsin or under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent petitions the Board of Nursing for re-licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license granted shall be in the discretion of the Board.

4. Within 120 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$300.00.
