The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

# FINDINGS OF FACT

1. Respondent Judith L. Chantelois, M.D., (dob December 5, 1955), is licensed in the State of Wisconsin to practice medicine and surgery, having license number 43193-20, first issued on April 18, 2001, with registration current through October 31, 2013. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 3530 Sanders Creek Road, Dillwyn, VA 23936.

2. On March 20, 2013, Respondent entered into a Consent Order with the Virginia Board of Medicine in which she voluntarily surrendered her Virginia license to practice medicine and surgery due to inability to practice for health reasons. Respondent has not been practicing medicine since May 2011. 3. A true and correct copy of the Consent Order from the Virginia Board of Medicine is attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.

4. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

#### <u>ORDER</u>

1. The attached Stipulation is accepted.

2. The SURRENDER of the license by Judith L. Chantelois, M.D., (license no. 43193-20) to practice medicine and surgery in the State of Wisconsin and the right to renew that license is hereby accepted, effective the date of this Order.

3. In the event that Respondent petitions the Wisconsin Medical Examining Board for re-licensure to practice medicine and surgery in the future, the Board may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license granted remains in the sole discretion of the Board.

4. Respondent shall return all indicia of current registration and licensure to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

#### **CONSENT ORDER**

The Virginia Board of Medicine ("Board") and Judith Lynn Chantelois, M.D., as evidenced by their signatures affixed below, agree to enter into this Consent Order affecting the license of Dr. Chantelois to practice medicine and surgery in the Commonwealth of Virginia.

#### FINDINGS OF FACT AND CONCLUSIONS OF LAW

The Board adopts the following findings of fact and conclusions of law in this matter:

1. Dr. Chantelois was issued license number 0101-245734 by the Board to practice medicine and surgery in the Commonwealth of Virginia on May 20, 2009. Said license expired on December 31, 2012, due to non-renewal.

2. Dr. Chantelois is in violation of Section 54.1-2915.A(4) of the Code of Virginia (1950), as amended ("Code") in that, by her own admission, she is unable to safely practice medicine due to significant, impairing physical and mental health conditions, including, but not limited to depression, anxiety, and decreased control of fine motor skills.

3. Due to these health conditions, Dr. Chantelois reports that she has not practiced medicine since May, 2011.

4. Recognizing her inability to practice, Dr. Chantelois did not renew her license in December, 2012 and informed the investigator from the Department of Health Professions in writing on January 2, 2013, that she does not intend to return to the practice

of medicine in the future, based upon her belief that she will not be able to recover sufficiently to do so.

#### CONSENT

I, Judith Lynn Chantelois, M.D., by affixing my signature hereto, acknowledge that:

 I have been advised specifically to seek the advice of counsel prior to signing this document;

2. I am fully aware that without my consent, no legal action can be taken against me, except pursuant to the Virginia Administrative Process Act, § 2.2-4000.A <u>et seq.</u> of the Code of Virginia;

3. I have the following rights, among others:

a. the right to an informal conference before the Board;

b. the right to appear in person or by counsel, or other qualified representative before the agency; and

4. I waive all rights to an informal conference;

5. I admit the truth of the above Findings of Fact and Conclusions of Law contained herein and agree not to contest the Findings of Fact or Conclusions of Law or any sanction imposed hereunder in any future judicial or administrative proceeding where the Board is a party; and

6. I consent to the following Order affecting my license to practice medicine and surgery in the Commonwealth of Virginia.

#### **ORDER**

WHEREFORE, based on the foregoing Findings of Fact and Conclusions of Law, and with the consent of the licensee, it is hereby ORDERED that the Board accept the VOLUNTARY SURRENDER of the PRIVILEGE TO RENEW the license of Judith Lynn Chantelois, M.D., to practice medicine and surgery in the Commonwealth of Virginia.

Upon entry of this Consent Order, the license of Dr. Chantelois will be recorded as SURRENDERED and no longer current.

Should Dr. Chantelois seek reinstatement of her license, she shall be noticed to appear before the Board, in accordance with the Administrative Process Act. As petitioner, Dr. Chantelois has the burden of proving her competency and fitness to practice medicine and surgery in the Commonwealth of Virginia in a safe manner.

Pursuant to Section 54.1-2400.2 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.
