The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Chiropractic Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent, Susan M. Droessler (dob February 23, 1959) is licensed in the State of Wisconsin as a chiropractic technician, having license number 702-114, first issued on July 1, 2010 and expired on December 14, 2010. Pursuant to Wis. Stat. § 440.08, Respondent retains the right to automatically renew her license upon payment of a fee until December 14, 2015. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is P.O. Box 126, Columbus, Wisconsin 53925.

- 2. At all times relevant to this proceeding, Respondent was working as a chiropractic technician at Droessler Chiropractic located at 1349 Park Avenue in Columbus, Wisconsin.
- 3. On December 12, 2012, a criminal complaint was filed by the Wisconsin Department of Justice (Columbia County Case Number 2012 CF 0556) against Respondent. The criminal complaint accused Respondent of one (1) count of theft-business setting in an amount greater than \$10,000, a violation of Wis. Stats. § 943.20(1)(b).
- 4. On August 19, 2013, Respondent entered a guilty plea and was convicted of one (1) count of theft-business setting in an amount greater than \$10,000, a violation of Wis. Stats. § 943.20(1)(b).
- 5. Respondent's conduct of using her access of personal and business information for her own financial gain relates to her practice as a chiropractic technician since, as part of her duties, she has access to business and patients' assets and/or personal information of a valuable nature.
- 6. Respondent acknowledged, by entering a guilty plea to the above charge, that she purposely deceived and defrauded both individuals and institutions of their assets.
- 7. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Chiropractic Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 446, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent, Susan M. Droessler, violated Wis. Stat. § 446.04(1) by engaging in conduct of a character likely to deceive or defraud the public.
- 3. By the conduct described in the Findings of Fact, Respondent, Susan M. Droessler, violated Wis. Admin. Code § CHIR 6.02(24) by being convicted of a crime substantially related to the practice of chiropractic.
- 4. By the conduct described in the Findings of Fact, Respondent, Susan M. Droessler, violated Wis. Admin. Code § CHIR 6.02(25) by violating any provision of Wis. Stats. § 446.
- 5. By the conduct described in the Findings of Fact, Respondent, Susan M. Droessler, violated Wis. Admin. Code § CHIR 6.02(26) by violating a law, or aiding or abetting the violation of any law related to the practice of chiropractic.
- 6. As a result of the above violations, Susan M. Droessler is subject to discipline pursuant to Wis. Stat. § 446.03.

<u>ORDER</u>

- 1. The attached Stipulation is accepted.
- 2. Respondent agrees to voluntarily surrender her right, pursuant to Wis. Stat. § 440.08, to renew her license to practice as a chiropractic technician in the State of Wisconsin upon payment of a fee. In the event that Respondent applies for Wisconsin licensure in the future, the applicable credentialing authority may limit that license to address the findings of fact based upon this stipulation, without further notice or hearing, and Respondent hereby expressly waives all rights to a hearing on any such limitation.
- 3. Within fourteen (14) days from the date of this Order, Respondent Susan M. Droessler shall mail or physically deliver all indicia of certification to the Department Monitor at the address below:
