On July 9, 2001, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order accepting the surrender of Respondent's professional nursing license (#111412-30). On July 25, 2012, Respondent's request for full reinstatement of her surrendered license was denied but she was granted a limited license for the sole purpose of completing a board-approved nurse refresher course. The limited license was valid for one year and shall not be renewed except by petition to the Board.

On December 19, 2013, the Board considered Respondent's request for renewal of the limited license. Based upon the information of record, the Board finds and makes the following:

### <u>ORDER</u>

1. Respondent is hereby GRANTED renewal of the limited license (#111412-30) for one year for the sole purpose of taking the nurse refresher course pursuant to Wis. Admin. Code N 5.08(2)(b). This limited license will not be renewed.
