On January 9, 2002, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice dentistry (#3331-15) for an indefinite period. Respondent was subsequently granted a stay of suspension, allowing him to practice with a limited license under certain terms and conditions.

On September 18, 2012, the Board removed Respondent's stay of suspension for violation of the Order. The Board ordered Respondent not to petition for reinstatement of the stay until he has been in compliance with the orders dated January 9, 2002, November 5, 2008 and September 18, 2012 for six (6) consecutive months.

On January 8, 2014, the Board considered Respondent's petition for reinstatement of the stay. Respondent appeared, accompanied by his attorney, on behalf of his request. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for reinstatement of the stay of suspension is hereby DENIED.
2. Due to non-compliance with the order dated September 18, 2012, Respondent shall not petition the Board for modifications or a stay of suspension until he has demonstrated twelve (12) consecutive months of absolute compliance. Aside from the 12-month compliance requirement, all other terms of the September 18, 2012 order remain in effect.
3. This order is effective the date of its signing.
