On September 14, 2005, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's respiratory care practitioner's credential for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.
