On, February 24, 2012, the Wisconsin Pharmacy Examining Board ("Board") issued an Order of Suspension with Granting of an immediate stay of suspension and his license is currently limited with certain terms and conditions.

On June 4, 2014, the Board considered Respondent's request for a reduction in individual and/or group therapy and a reduction in drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for reduction in individual and/or group therapy sessions from weekly to monthly is hereby GRANTED.
2. Respondent's request for a reduction of the number of required drug and alcohol screens is hereby DENIED due to insufficient time under the Order.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
