On April 9, 2008, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order accepting the surrender of the Respondent's pharmacy license. On February 24, 2012, the Board granted Respondent's petition for reinstatement of his license to practice as a pharmacist with an indefinite suspension. The Board immediately stayed the suspension subject to conditions and limitations ("Order").

On December 10, 2014, the Board considered Respondent's request for termination of the treatment requirements found in C.1 through C.5 of the Order. Based upon the information of record, the Board finds and makes the following:

## **ORDER**

- 1. Respondent's request for termination of the treatment requirements found in C.1 through C.5 of the Order is hereby DENIED.
- 2. The Board hereby grants Respondent a stay of the treatment requirements found in C.1 through C.5 of the Order until he resumes employment as a pharmacist, at which time Respondent shall resume the treatment requirements found in C.1 through C.5 of the Order.
- 3. All other terms and conditions of the Order, dated February 24, 2012, not otherwise modified remain in full force and effect.
  - 4. This order is effective the date of its signing.
