On November 3, 2008, the Wisconsin Cosmetology Examining Board\* issued a Final Decision and Order ("Order") requiring Respondents, jointly and severally, to pay \$500.00 in proceeding costs and a \$500.00 forfeiture within 30 days. Respondents were later granted a payment plan in which the balance was to be paid in 12 monthly payments beginning July 2011.

On November 13, 2014, Respondent Garner's barbering and cosmetology manager license, Respondent Gee's Clippers' establishment license, and Respondent Smith's ability to renew his barbering and cosmetology manager license, were suspended for failure to pay as ordered. Based upon the information of record, which includes proof that Respondents have now paid the costs of the proceeding and the forfeiture in full, the following is entered:

## **ORDER**

- 1. The suspension of Respondent Garner's manager license (#30700-81) and Respondent Gee's Clippers' establishment license (#24265-80) is terminated and the licenses are hereby returned to full, unrestricted status.
- 2. Respondent Smith's ability to renew his manager license (#26335-81) is no longer suspended for this matter.
  - 3. This order is effective the date of its signing.
