On December 4, 2008, the Wisconsin Real Estate Examining Board (formerly known as the Real Estate Board) issued a Final Decision and Order ("Order") requiring Respondent to pay \$250.00 in costs of the proceeding and a forfeiture of \$500.00 within 120 days. Interest in the amount of 12% per annum accrues to all unpaid costs of the proceeding. The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and forfeiture as ordered and as a result, the following is entered:

ORDER

1. Respondent's real estate business entity credential (#835645-91) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding, plus interest, and forfeiture in full.
3. This order is effective the date of its signing.
