On October 20, 2011, the Wisconsin Board of Nursing ("Board") issued an Order Granting Reinstatement of License with Limitations ("Order"), which reinstated Respondent's professional nursing license with an indefinite suspension following a previous revocation on December 3, 2009. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On June 12, 2014, the Board considered Respondent's request for the return of full licensure or termination of the direct supervision requirement. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her professional nursing license (#138267-30) to full, unrestricted status is hereby DENIED due to insufficient time under the Order to show compliance.
2. The Board hereby APPROVES ResCare as a work-setting for Respondent pursuant to Paragraph C21 of the Order.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
