On May 11, 2010, the Wisconsin Real Estate Examining Board ("Board") issued an Order Granting Limited License as a Real Estate Salesperson ("Order"). The Order granted Respondent a license to practice as a real estate salesperson with certain limitations once she completed the application for licensure.

On February 20, 2014, the Board considered Respondent's request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her real estate salesperson license (#42000-94) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
