On September 13, 2010, the Wisconsin Barbering and Cosmetology Examining Board (now known as the Cosmetology Examining Board) issued a Final Decision and Order, number 0000414, to the above Applicants, limiting their licenses for a period of five years. To date, the Order remains in effect and the Applicants' licenses remain limited. On or about July 14, 2014, A Glo Spa & Salon Co., owned by Christi J. Newell, applied for a new Establishment License as the establishment was moving to a different location which necessitated a change in address.

The Cosmetology Examining Board, after review of the submitted application materials, has decided to approve the application for Establishment license subject to the Final Decision and Order, number 0000414. Such Order remains in effect until the terms are fulfilled, regardless of the establishment address change.

IT IS HEREBY ORDERED that the application for Establishment License submitted by A Glo Spa & Salon Co., owner Christi J. Newell, is approved and remains subject to the September 13, 2010 Final Decision and Order, number 0000414.
