On November 1, 2010, the Wisconsin Cosmetology Examining Board* ("Board") issued a Final Decision and Order ("Order") requiring Respondent to pay \$3200.00 in forfeiture and costs of the proceeding in monthly instalments to be completed by May 19, 2013.

On July 10, 2013, the Board issued an Order Granting Extension of Time to Pay on the Payment Plan. The Order required Respondent to make a minimum payment of \$300.00 commencing August 1, 2013, and payment of \$300.00 every 90 days until the total amount was paid in full. The information of record demonstrates that Respondent has failed to complete payment of the forfeiture and costs of the proceeding as ordered and, as a result, the following is entered:

ORDER

- 1. Respondent's barbering or cosmetology manager license (#18905-81) is hereby SUSPENDED.
- 2. The suspension shall remain in effect until Respondent has paid the forfeiture and costs of the proceeding in full.
 - 3. This order is effective the date of its signing.
