On November 9, 2010, the Wisconsin Funeral Directors Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$643 in costs of the proceeding within one hundred twenty (120) days. Interest of 12% per annum in the amount of \$227.89 has since accrued to the amount, making the total now due \$870.89. The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and accrued interest as ordered and, as a result, the following is entered:

ORDER

1. Respondent's Funeral Director credential (#5199-77) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full, including the accrued interest.
3. This order is effective the date of its signing.
