On May 25, 2011, the Wisconsin Veterinary Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license with certain conditions. Respondent is eligible to have the limitation removed from his license upon completion of several educational programs, evidence of his employer's compliance with the Animal Welfare Act, 2009 Wisconsin Act 90 and submission of a surgical competency assessment approved pursuant to the Order.

Respondent has submitted proof that he successfully completed the Board-ordered requirements and, as a result, the following is entered:

ORDER

1. Respondent's veterinary license (#6099-50) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
