On July 20, 2011, the Medical Examining Board ("Board") issued a Final Decision and Order ("Order") accepting the surrender of Respondent's license to practice medicine and surgery in the state of Wisconsin. In the event Respondent ever applies for any credential, he shall provide proof, sufficient to the Board, that he can practice medicine and surgery with reasonable safety and skill. Respondent's first request for permission to reapply for licensure was denied by the Board on March 7, 2013.

On February 19, 2014, the Board considered Respondent's second request for permission to reapply for licensure in Wisconsin. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for permission to reapply for licensure is hereby DENIED because he has failed to provide sufficient evidence of his ability to practice medicine and surgery with reasonable skill and safety.
2. This order is effective the date of its signing.
