On September 1, 2011, the Wisconsin Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") suspending Respondent's substance abuse counselor in-training certification (#13705-130) for an indefinite period. Respondent was required to complete certain conditions prior to petitioning the Department for termination of the suspension.

On August 13, 2014, the Department considered Respondent's request for termination of the suspension. Based upon the information of record, the Department finds and makes the following:

ORDER

1. Respondent's request for termination of the suspension is hereby GRANTED.
2. If Respondent successfully completes all requirements for certification as a clinical substance abuse counselor or all requirements for any other credential issued by the Department, that certification or credential shall be subject to such terms and conditions as the Department deems appropriate.
3. This order is effective the date of its signing.
