


On November 10, 2011, the Wisconsin Department of Safety and Professional Services issued an Order Granting Limited License ("Order") to Applicant for a private security permit. Among other terms, the Order requires that Applicant successfully complete an anger management program and arrange for his security guard supervisor(s) to submit quarterly work reports. The information of record demonstrates that Applicant has not provided proof of completing anger management or complied with the quarterly reporting requirement and, as a result, the following is entered:

ORDER

1. Applicant's private security person permit credential (#44316-108) is hereby SUSPENDED.
2. The suspension shall remain in effect until Applicant has complied with the terms of the Order.
3. This order is effective the date of its signing.
