On April 2, 2012, the Wisconsin Cosmetology Examining Board ("Board") issued a Final Decision and Order ("Order") reprimanding Respondents and requiring each to pay \$1,500.00 in forfeiture and \$400.00 in costs of the proceeding, for a combined total of \$3,800.00. Payments were to be made at a rate of \$316.67 each month for twelve months, with the balance to be paid in full by May 1, 2013.

Respondents have paid a combined total of \$2,167.00 to date, leaving a balance of \$1,633.00. On April 15, 2014, the Board considered Respondent Nealy's request for a modified payment plan of \$100.00 per month until the combined balance is paid in full. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a modified payment plan is hereby DENIED.
2. This order is effective the date of its signing.
