On April 19, 2012, the Wisconsin Engineer Section of the Examining Board of Architects, Landscape Architects, Professional Engineers, Designers, and Land Surveyors ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional engineer credential. Respondent was required to complete thirty hours of education from the Basic Level Study in Engineering Ethics pursuant to the Order. Respondent was also required to have any work in the area of electrical engineering reviewed by a supervising engineer pre-approved by the Section or its designee.

Respondent has submitted proof that he successfully completed the Board-ordered education and has complied with the supervision requirement. As a result, the following is entered:

ORDER

1. Respondent's professional engineer credential (#15820-6) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
