FINDINGS AND ORDER		WI DEPT OF JUSTICE DIVISION OF LEGAL SERVICES

The above captioned matter having come before this Court for a briefing schedule conference, and there having been the following appearances: Attorney Troy Klarkowski appeared via telephone and on behalf of the petitioner; Attorney Bruce Olsen appeared via telephone and on behalf of the State of Wisconsin Auctioneer Board.

#### FINDINGS OF FACT

1. Dean K. George is principally employed as an Auctioneer
2. The Auctioneer Board suspended Mr. George's license to practice as an auctioneer
3. This Court will ultimately decide whether the actions of the Auctioneer Board were arbitrary, capricious, or otherwise inconsistent with the law.
4. That there exists a potential of irreparable harm to Mr. George if he prevails on his petition.
5. That there exists a legitimate state interest in securing costs of the action if the Auctioneer Board prevails.
6. That the costs of this action, to date, as assessed by the Auctioneer Board, are \$16,428.88.
7. That Dean K. George has indicated he has paid \$7,200 towards the costs.

#### IT IS HEREBY ORDERED

8. The suspension imposed by the Board is hereby stayed pending a decision by this Court on the petition.
9. That Dean K. George shall post \$9,000 bond with the Clerk of this Court as security for the costs of this action. The bond shall be posted on or before July 25, 2014.
10. Pleadings may be amended by any party filing any necessary and proper paperwork with this Court on or before July 18, 2014.
11. Petitioner is to file a brief in support of his petition on or before August 1, 2014. The State shall file its response on or before August 22, 2014. Petitioner may file a reply brief on or before September 5, 2014.
12. Briefs should be filed with the Clerk of this Court with a courtesy copy electronically sent to the Court's Judicial Assistant at [adam.dassow@wicourts.gov](mailto:adam.dassow@wicourts.gov)
13. Failure to comply with the terms of this order shall be considered cause for imposing sanctions which may include dismissal, default judgment, contempt, money terms, orders limiting or barring the presentation of testimony or introduction of evidence at trial, or a

combination thereof, or any such added and further sanctions as the Court may deem appropriate according to law.
