ORDER FIXING COSTS

On April 28, 2014, the Auctioneer Board (Board) issued its *Final Decision and Order on Remand with Variance*, DHA Case No. SPS-11-0069 and Order No. 0001937, in the above-captioned matter. Per that Order, the Board reinstated the July 20, 2012 Final Decision and Order; ordered that the Respondent shall fulfill all of the remaining conditions of his discipline and pay all of the remaining costs ordered by the July 20, 2012 Final Decision and Order; ordered that the Respondent shall pay all costs of the further disciplinary proceedings conducted after this matter was remanded on July 1, 2013 and that the amount of costs is to be established pursuant to Wis. Admin. Code § SPS 2.18 and; ordered that the Respondent shall pay all costs within ninety (90) days of the Order Fixing Costs.

On October 21, 2014, the Board was presented with the Division of Legal Services' (Division) request that the Board issue an Order Fixing Costs in the matter of the disciplinary proceedings against the Respondent. The Division's request was submitted in compliance with the April 28, 2014 Board Order and covered those costs incurred after the matter was remanded on July 1, 2013 and through April 28, 2014. Those costs amounted to \$11,552.13. The Board reviewed the Affidavits of Costs from the Division of Legal Services and Compliance (Division), and Division of Hearings and Appeals, as well as Respondent's objections to costs and the Division's response. After considering all submissions during the Board meeting on October 21, 2014, the Board orders as follows:

ORDER

The costs of the proceeding (from July 1, 2013 through April 28, 2014), in the amount of \$11,552.13, are assessed against Respondent pursuant to Wis. Stat. § 440.22 and Wis. Admin. Code § SPS 2.18. Costs shall be paid no later than 90 days from the date of this order. Pursuant to Wis. Stat. § 440.22(3) the Department may not restore, renew or otherwise issue any credential to the Respondent until costs are paid in full.
