On August 16, 2012, the Wisconsin Real Estate Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$2,250.00 in costs of the proceeding and forfeiture, in \$250 increments, by May 15, 2013. Respondent was also ordered to complete fifteen (15) hours of education in "trust accounts and contracts or approved forms" and three (3) hours of education in "ethics," both within one year from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and forfeiture and failed to complete the Board-ordered education. Therefore, the following is entered:

ORDER

- 1. Respondent's license to practice as a real estate broker in the state of Wisconsin (#55409-90) is hereby SUSPENDED.
- 2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding and forfeiture in full and has demonstrated successful completion of the education requirements of the Order.
 - 3. This order is effective the date of its signing.
