On September 19, 2012, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery for twelve (12) months. The suspension was stayed throughout its entirety, allowing Respondent to practice under a limited license with certain terms and conditions. Upon termination of the suspension Respondent license was to remain permanently limited as follows:

> "Respondent shall have a female employee present during any intimate examination of a female patient, including pelvic, breast, buttock and rectal examinations, and during any examination during which an intimate part is likely to be exposed. Respondent shall document the identity of the female employee in the patient health care record."

On February 19, 2014, the Board considered Respondent's request for removal of the permanent limitation and the return of his license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

- Respondent's request for the return of his license to practice medicine and surgery 1. (#29828-20) to full, unrestricted status is hereby GRANTED.
- All limitations and encumbrances upon Respondent's credential are hereby 2. removed.
 - 3. This order is effective the date of its signing.
