On October 29, 2012, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") suspending Respondent's clinical substance abuse counselor and independent clinical supervisor credentials in the state of Wisconsin for an indefinite period. Respondent has been granted a stay of suspension and her credentials are currently limited with certain terms and conditions.

The information of record demonstrates that Respondent is in substantial or repeated violation of Section C of the Order and, as a result, the following is entered:


ORDER

1. Respondent's clinical substance abuse counselor credential (#13700-132) and independent clinical supervisor credential (#15174-135) are hereby SUSPENDED.

2. It is further ordered that Respondent may petition the Department for reinstatement of the stay of suspension upon demonstrating, to the satisfaction of the Department or its designee, compliance with the provisions of Sections C and D of the Order for the most recent three (3) consecutive months.

3. This order is effective the date of its signing.
