On November 12, 2012, the Wisconsin Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") suspending Respondent's substance abuse counselor credential for one year. After the suspension period has concluded, Respondent's credential shall be limited with certain terms and conditions including the completion of ethics and boundaries education and a restriction against providing treatment services to women or minors.

Respondent has petitioned the Department and requested that the Order be modified to allow him to provide treatment services to minors. Based upon the information of record, including proof that Respondent has completed the required education, the Department finds and makes the following:

### <u>ORDER</u>

1. Respondent's request to be allowed to treat minors is hereby GRANTED. Respondent may provide services to adult male clients and minors but shall not provide services to adult women.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

3. This order is effective the date of its signing.
