On November 1, 2013, the Wisconsin Medical Examining Board ("Board") removed Respondent's stay of suspension for violation of the Final Decision and Order dated November 14, 2012 ("Order"). Respondent may petition the Board for reinstatement of the stay upon demonstrating continuous compliance with the Order for at least the most recent three months.

On March 19, 2014, Respondent appeared before the Board on behalf of his petition for reinstatement of the stay and modifications of the Order including: a reduction in drug screens; permission to travel abroad; termination of the alcohol restriction; and a reduction in the length of the Order. Based upon the information of record, the Board finds and makes the following:

ORDER

1. The suspension of Respondent's license (#34129-20) is hereby STAYED pursuant to the Order.
2. Respondent's request for modifications of the Order is GRANTED as follows:
 - a. The frequency of Respondent's drug screens is hereby reduced to 24 per year.
 - b. Respondent may travel abroad and random drug screens will be suspended during such time. All travel must be pre-approved by the Department Monitor at least two weeks prior to departure.
 - c. The limitation prohibiting the consumption of alcohol by Respondent is hereby terminated and all further alcohol screenings are removed.
3. Respondent's request to shorten the length of the Order is hereby DENIED.
4. All other terms of the Order not otherwise modified remain in effect.
5. This order is effective the date of its signing.
