On February 13, 2013, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's pharmacy license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

Information submitted in support of Respondent's request for a reduction in the frequency of drug and alcohol screens has been reviewed. Based upon the information of record, which demonstrates that Respondent is eligible for a temporary reduction at this time, the following is entered:

<u>ORDER</u>

1. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to 14 urine screens per year and one annual hair test until he obtains employment as a pharmacist, at which time the frequency will be increased to 49 screens per year including one annual hair test.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

3. This order is effective retroactively to July 24, 2014.
