On February 13, 2013, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's Certified Residential Appraiser and Licensed Appraiser credential. Respondent was ordered to complete 45 hours of education on the topic of USPAP requirements, chosen from the courses listed in the Order, and he was prohibited from supervising or training any uncredentialed or credentialed appraiser for a period of one year.

Respondent has submitted proof that he successfully completed the terms of the Order and, as a result, the following is entered:

ORDER

1. Respondent's Certified Residential Appraiser and Licensed Appraiser credential (#1672-9) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
