On May 9, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license and advanced practice nurse practitioner certification for an indefinite period. Respondent has been granted a stay of suspension and her credentials are currently limited with certain terms and conditions.

On May 8, 2014, the Board considered Respondent's request for the return of her credentials to full, unrestricted status. Respondent appeared in support of her request. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her professional nursing license (#137287-30) and her advanced practice nurse practitioner certification (#2730-33) to full, unrestricted status is hereby DENIED due to insufficient time under the Order to demonstrate adequate compliance.
