On May 20, 2013, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") requiring Respondent to pay 900.00 in costs of the proceeding and complete education in 8 hours in ethics and boundaries for substance abuse counselors within 90 days from the date of the Order.


The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the Board-ordered education and, therefore, the following is entered:

ORDER

1. Respondent's license to practice as a substance abuse counselor in the state of Wisconsin (#14355-132) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
