On June 24, 2013, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay a forfeiture of \$1,000.00. Respondent was granted a payment plan of \$250 due every 60 days from the date of the previous payment. On January 7, 2014, Respondent's establishment credential was suspended for failure to pay the forfeiture as ordered.

Based upon the information of record, which includes proof that Respondent has now paid the forfeiture in full, the following is entered:

#### **ORDER**

- 1. The suspension is terminated and Respondent's establishment credential (#36564-80) is hereby returned to full, unrestricted status.
  - 2. All limitations and encumbrances upon Respondent's credential are removed.
  - 3. This order is effective the date of its signing.
