On May 23, 2013, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") requiring Respondent to complete 75 hours of education consisting of three courses offered by the Appraisal Institute within 150 days, including taking and passing any course exams. Respondent completed the coursework but has not passed the exams for two of the three courses, specifically General Appraiser Income Approach Part 1 and General Appraiser Market Analysis and Highest and Best Use.

On May 7, 2014, the Board considered Respondent's request to deem the education requirements complete or allow him to take alternative courses relating to residential appraisals. Based upon the information of record, the Board finds and makes the following:

ORDER

Respondent's request for modification is hereby GRANTED, allowing him to 1. satisfy provisions 4.a.i. and 4.a.ii. of the Order as follows:

Respondent shall complete 30 hours of coursework, with a testing a. component and preapproved by the Board Monitoring Liaison, in residential appraisals.

b. The coursework shall be completed, including taking and passing the testing component, within 60 days of the date this order is signed.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

3. This order is effective the date of its signing.
