On June 4, 2013, the Wisconsin Land Surveyors Section of the Examining Board of Architects, Landscape Architects, Professional Engineers, Designers, and Land Surveyors (Section) issued its Final Decision and Order in the above-captioned matter requiring that; pursuant to §440.22, Wis. Stats., the costs of this proceeding be assessed against Respondent. On October 29, 2013, the Section issued an Order Fixing Costs requiring Respondent to pay \$1,527.95 on or before April 25, 2014. The information of record demonstrates that Respondent has failed to pay the costs of the proceeding as ordered.

On June 4, 2013, the Section also ordered Respondent to file quarterly reports. The information of record demonstrates Respondent has failed to do so.

As a result, the following is entered:

<u>ORDER</u>

1. Respondent's Land Surveyor credential (#2664-8) is hereby SUSPENDED.

2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding plus the interest accrued for non-payment in full. The amount currently due is \$1,691.93. The Respondent must also file the quarterly reports as ordered.

3. This order is effective the date of its signing.
