On May 29, 2013, the Wisconsin Veterinary Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete 16 hours of education; ten (10) in general practice of veterinary medicine, three (3) in ethics and (3) in record keeping, all within 180 days from the date of the Order.

The information of record demonstrates that Respondent has failed complete the Board-ordered education and, therefore, the following is entered:

ORDER

- 1. Respondent's license to practice veterinary medicine in the state of Wisconsin (#3918-50) is hereby SUSPENDED pursuant to provision six (6) of the Order.
- 2. The suspension shall remain in effect until Respondent has demonstrated successful completion of the education requirements of the Order.
 - 3. This order is effective on October 10, 2014.
