On June 27, 2013, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondents' real estate broker and real estate business entity credentials. Respondent Adolf Pavelec was required to complete six (6) hours of education on the topic of trust accounts and/or bookkeeping, pursuant to the Order. Respondent Adolf Pavelec and Respondent Pavelec Realty were also required to submit monthly reports on the business trust account, pursuant to the Order.

Respondents have submitted proof that Respondent Adolf Pavelec has successfully completed the Board-ordered education and that the trust account reports are now acceptable and, as a result, the following is entered:

ORDER

1. Respondent Adolf E. Pavelec's real estate broker credential (#29902-90) is returned to full, unrestricted status.
2. Respondent Pavelec Realty's real estate business entity credential (#13271-91) is returned to full, unrestricted status.
3. All limitations and encumbrances upon Respondents' credentials are removed.
4. This order is effective the date of its signing.
