On June 27, 2013, the Wisconsin Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") limiting Respondent's substance abuse counselor certificate with several terms and conditions, including the requirement to complete four hours of education on the topic of record keeping offered by a provider preapproved by the Department's designee within 90 days.

The information of record demonstrates that Respondent has failed to comply with the Department-ordered education and, as a result, the following is entered:

## **ORDER**

- 1. Respondent's substance abuse counselor certificate (#15387-131) and the clinical supervisor-in-training certificate (#15451-133) are hereby SUSPENDED.
- 2. The suspension shall remain in effect until Respondent has demonstrated successful completion of the education requirements of the Order.
  - 3. This order is effective the date of its signing.
