On August 14, 2013, the Professional Counselor Section ("Section") of the Wisconsin Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") limiting Respondent's professional counselor license with several terms and conditions, including the requirement to complete four hours of education on the topic of record keeping offered by a provider pre-approved by the Section's monitoring liaison within 90 days.

The information of record demonstrates that Respondent has failed to comply with the Section-ordered education and, as a result, the following is entered:

### <u>ORDER</u>

1. Respondent's professional counselor license (#4394-125) is hereby SUSPENDED.

2. The suspension shall remain in effect until Respondent has demonstrated successful completion of the education requirements of the Order.
