On August 14, 2013, the Professional Counselor Section of the Wisconsin Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$500.00 in costs of the proceeding within 90 days. The Respondent was subsequently granted a 90 day extension of time to pay the costs. The information of record demonstrates that Respondent has failed to pay the costs of the proceeding as ordered and, as a result, the following is entered:

ORDER

1. Respondent's professional counselor credential (#4472-125) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full.
