On October 1, 2013, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") requiring Respondent to pay \$1,033.00 in costs of the proceeding within 90 days from the date of the Order. Respondent was also required to complete six (6) hours of education in "proper record keeping" and six (6) hours of education in "ethics" within 120 days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education as ordered, therefore, the following is entered:

ORDER

1. Respondent's license to practice as a substance abuse counselor-in-training in the state of Wisconsin (#15740-130) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
